



## Sesh Space Community Guidelines

**Important:** Sesh Space is privacy-first. Short retention and end-to-end encryption reduce what can be reviewed after content expires. Users should preserve screenshots for reports.

### 1. Purpose

Sesh Space is meant to be a private social space, not a free-for-all. These Guidelines explain the standards for respectful participation and what conduct can lead to warnings, content removal, feature restrictions, suspension, or removal from the service.

### 2. Treat People Like People

Harassment, bullying, repeated unwanted contact, intimidation, humiliation, threats, hateful abuse, and targeted ridicule are not allowed. Differences of opinion do not excuse abusive conduct.

### 3. No Hate or Identity-Based Abuse

Content attacking or demeaning people based on race, ethnicity, nationality, religion, disability, sex, gender, gender identity, sexual orientation, age, or similar protected characteristics is prohibited.

### 4. No Threats, Violence, or Coercion

Threats of violence, glorification of violence, extortion, coercive demands, blackmail, and encouraging self-harm or harm to others are prohibited. Credible threats may result in immediate account action.

### 5. No Doxxing or Invasion of Privacy

Do not share someone else's address, phone number, personal images, legal name, workplace, identifying details, precise location, or other private information without permission. Do not expose or weaponize private facts.

### 6. Consent Matters

Do not share non-consensual intimate imagery, sexual coercion, exploitative sexual content, or content that violates another person's consent or dignity.

### 7. No Illegal Use

Do not use Sesh Space to facilitate illegal transactions, unlawful distribution, prohibited coordination, or prohibited conduct. Cannabis-related discussion does not override local, state, tribal, territorial, or federal law. Users are responsible for following the laws that apply where they are located.

## 8. No Fraud, Spam, or Deception

Do not impersonate others, staff accounts, verified businesses, dispensaries, or brands. Do not run scams, send spam, use bots without authorization, phish for credentials, misrepresent affiliation, mislead users about identity or intent, or manipulate platform features.

## 9. Protect the Platform

Do not attempt to bypass account controls, scrape private data, abuse demo links, break security protections, interfere with platform reliability, misuse push notifications, or attempt to decrypt, intercept, or access communications that are not your own.

## 10. SeshFeed, SeshCircle, SeshTalk, SeshMap, and SeshStrain Behavior

Use SeshFeed, SeshCircle, SeshTalk, SeshMap, and SeshStrain respectfully. Do not post misleading strain information as verified fact, misuse map features to harass people, create circles for unlawful purposes, spam boards, or use community features to pressure or target others.

## 11. Business, Listings, and Advertising Rules

Users and businesses may not mislead users about products or services, promote illegal transactions, impersonate verified dispensaries or brands, make unsupported medical or safety claims, advertise to prohibited audiences, or use sponsored content to evade platform rules. All promotions must comply with applicable cannabis regulations and advertising laws in the user's and advertiser's jurisdiction.

## 12. Reporting and Temporary Content

Because feed posts expire and private messages are encrypted and short-lived, users should capture screenshots promptly when misconduct occurs. Reports without evidence may be difficult to verify after content expires. Include usernames, dates, times, listing names, ad screenshots, and surrounding context when possible.

## 13. Enforcement

Depending on severity and context, Sesh Space may issue warnings, remove content, restrict features, suspend accounts, remove accounts, ban emails, revoke demo links, remove ads, reject listings, or permanently ban users or advertisers. Some conduct may result in immediate removal without prior warning.

## 14. Appeals

If enforcement action is taken against your account, you may submit an appeal through the process described in the Appeals Policy. Some actions may not be appealable where required by law, urgent safety concerns, or severe violations.
